INVESTIGATION ON PETITION FOR THE THREE DEGREES Free and ...

After investigation, the Committee may, as set out in the Act: 4.1 dismiss the complaint; 4.2 make recommendations to the member, licensee or certificate holder; 4.3 refer the matter for review to the Practice Review or Conduct Review Committee established under the Bylaws; or 4.4 recommend an inquiry to the Discipline Committee.
